Engineer's Report

Engineer, John Seamans gave a report to the board with the findings of a shoulder material study he conducted throughout the township. Approximately 170 tons of 2A aggregate material and 53 tons of rip rap will be needed to properly repair the shoulders of Maple Road, North Turnpike, North Overbrook and College Roads.

Zoning Officer's Report

Zoning officer Anthony Mengoni provided the supervisors with a report of his activity over the last month in advance of the meeting. The Simmons property is complying with the nuisance junk violation issued. He also responded to a Solar ordinance inquiry received.

Unfinished Business

Supervisor Gerry Henry attended a meeting for the Factoryville Ambulance Authority. He reported that the authority is still in the planning stages but requested the township approve an order of inclusion which would give the authority the right to bill residents for their services.

Brush clearing is planned in the township as soon as the contractor is able to schedule.
